The Board of Regents met in closed session on Monday, September 15, 2025 from 2:00 pm to 2:33 PM on Main Campus in the Student Union Building, Cherry Silver Room. The meeting was held in closed session under the following Open Meetings Act (NMSA 1978) exceptions: discussions of limited personnel matters as defined in and permitted by Section 10-15-1{H)(2}, NMSA (1978). Regents present in person were Paula Tackett, Paul Blanchard, Victor Reyes, Christina Campos, and Patti Williams. Jack Fortner attended virtually. There were no administrators present. The matters discussed were limited to those specified in the notice and agenda for the meeting; there were no matters upon which official action was taken.

CALL TO ORDER AND CONFIRMATION OF A QUORUM

Chair Paul Blanchard called the meeting to order at 10:30 a.m. in the UNM Student Union Building, Ballroom B and confirmed a quorum with a roll call vote with 5 members present (Blanchard, Campos, Reyes, Williams, and Fortner).

VOTE TO RE-OPEN THE MEETING

 The motion to re-open the meeting passed unanimously with five regents present and voting (1st Reyes; 2nd Fortner).

Regent Blanchard re-opened the meeting at 11:16 am in the Student Union Building, Ballroom B and certified that only matters listed in the above Executive Session agenda were discussed in Executive Session.

Land Acknowledgement Statement of the University of New Mexico

Regent Blanchard affirmed UNM's Land Acknowledgement Statement. Emily Morelli, Secretary to the Board of Regents, read it aloud:

Founded in 1889, The University of New Mexico sits on the traditional homelands of the Pueblo of Sandia. The original peoples of New Mexico - Pueblo, Navajo, and Apache - since time immemorial, have deep connections to the land and have made significant contributions to the broader community statewide. We honor the land itself and those who remain stewards of this land throughout the generations and also acknowledge our committed relationship to Indigenous peoples. We gratefully recognize our history.

PRESIDENT'S ADMINISTRATIVE REPORT

President Stokes presented information on increased Fall 2025 enrollment, the work of rapid response teams to the evolving landscape of federal funding, strategic planning, and enhancements to the student experience (ATTACHMENT A). She also announced her retirement with the following statement:

"As I approach eight years of service as your President—and after several wonderful decades of service in higher education leadership, it soon will be time for me to step away and begin a new chapter in my life with my husband, Jeff, who has served as my partner throughout this leadership journey. I have informed the Board of Regents that the 2025-26 academic year will be my last serving as your President. I am sharing this news with you and the Board of Regents now to ensure there is ample time for a search for my successor and a smooth transition.

When I first arrived on campus in February of 2018, I encountered an incredible community, amazing students, faculty and staff, and a collective desire to elevate the institution. While I will leave it to others to put my tenure into perspective, I am incredibly proud of what we have done together in alignment with UNM2040 and with our mission: promoting discovery, generating intellectual and cultural contributions, honoring academic values, and fostering an educated, healthy, and economically vigorous New Mexico. I am also proud of the work of our students, faculty, and staff over the years, all of whom have helped lift up the institution and improve the lives of our communities around the state. And I am proud that we accomplished so much together while living our shared values of excellence, inclusion, environment, integrity and place in our words and actions.

But I want to be clear – I am not going anywhere yet. There is still a great deal of work ahead of us this academic year as we move forward in pursuit of our vision and face head-on the challenges being encountered by higher education institutions across the country. I will continue to work on behalf of the University and the community each and every day until my term is over, and I will do everything I can to assist the Board of Regents in a smooth transition to better ensure UNM's future success and continued impactful service to New Mexico, a state I love and will always hold close to my heart.

It has been an honor to serve as your President. I'm grateful to the Board of Regents and the UNM community for their continued support. No matter where my journey into retirement takes me, I will always be a Lobo!"

REGENT COMMENTS

Regent Blanchard spoke on behalf of the regents to thank President Stokes for her visionary stewardship and outstanding commitment to UNM and wish her well in retirement. He also noted the board was committed to a robust search for the next president of UNM.

ADVISORS COMMENTS

Roberta Lavin, Faculty Senate President, introduced the current priorities of Faculty Senate - research, campus safety, and equity across UNM campuses.

Damion Terrell, Staff Council President, noted the upcoming management summit and outstanding supervisor awards. He also encouraged staff to support 0KUNM, KNME and Lobo Athletics. He also noted the retirement of Mary Clark, past Staff Council president.

Andrew Norton, ASUNM President, thanked the regents for all the work they do. He thanked the administration for safety improvements to campus. He noted that ASUNM is fully staffed and will be hosting a statewide conference for student leadership. He also thanked Athletics for collaborative efforts with students. He noted students are concerned about research funding.

Travis Broadhurst, President of GPSA, thanked President Stokes for her leadership. The GPSA Fall grant cycle is open, where grants and scholarships are awarded to graduate students. GPSA has increased appropriations to graduate student organizations and has many upcoming events. He also thanked Provost Rodriguez regarding her support of international graduate students. Lastly, another priority of GPSA will be healthcare benefits for graduate students.

Aprilyn Chavez Geissler, Alumni Association President, thanked the regents for their work on behalf of UNM. She reported on several recent and upcoming activities engaging alumni and supporting students.
